OFF Licence

Pursuant to the Sale and Supply of Alcohol Act 2012, ENCELADUS DISTILLING COMPANY LIMITED is authorised to sell alcohol on the premises situated at **Tenancy 6, Unit 30, 10 Railway Avenue, Upper Hutt** and known as **Enceladus Distilling Company**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.  
The licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

**CONDITIONS**

This licence is subject to the following conditions:

- (a) No alcohol is to be sold or delivered on Good Friday, Easter Sunday, or Christmas Day, or before 1pm on ANZAC Day.
- (b) The whole of premises is designated as a supervised area.
- (c) Drinking water must be freely available at all times samples are being provided.
- (d) Alcohol may be sold or delivered only on the following days and during the following hours:

**Monday to Sunday 7:00am to 11:00 pm**

- (e) the following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed: The Licensee or manager must ensure that:
  - i. patrons do not become intoxicated and where intoxicated persons do present themselves, they are not served further alcohol and are safely removed from the premises as soon as possible.
  - ii. statutory restrictions on the supply of alcohol to minors are observed at all times and evidence of age documents are requested where necessary.
  - iii. signs clearly stating the above requirements be placed at all points of sale.
- (f) the licence is also subject to the following conditions, which in the committee's opinion are not inconsistent with the Act:
  - i. Samples are not to exceed 10ml and are limited to one per person.
  - ii. All products sold through the onsite Off licence will not be put into branded packaging.
  - iii. Only products made by the licensee are to be sold.
  - iv. All remote sales requirements pursuant to Section 59 of the Sale and Supply of Alcohol Act 2012, and Regulations 14 and 15 of the Sale and Supply of Alcohol Regulations 2013 must be met when alcohol is sold by remote sale.

**DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE**


A copy of this licence must be displayed in the interior of the premises so as to be easily read by persons using the premises. The entrance is from **Tenancy 6, Unit 30, 10 Railway Avenue, Upper Hutt** and is designated as the principal entrance.


**DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force.

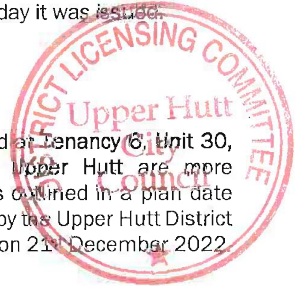
- (a) Either
  - Until the close of the period for which it was last renewed; or
  - If it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) If an application for the renewal of the licence is duly made before the licence would otherwise expire, Either
  - Until the close of the period of 3 years after the period for which it was last renewed; or
  - If it has never been renewed, until the close of the period of 4 years after the day it was issued.
